

Remembering Caron Wishart

Our friend and colleague Caron Wishart passed away peacefully on December 19, 2010, after a very courageous and determined battle with cancer. She fought that battle as she tackled so many challenges in life: with dignity, grace and conviction.

Caron's legacies are many. She began her 26-year career with the Law Society of Upper Canada as a claims examiner in the Law Society's E&O department. When LPIC became a full-fledged insurance company in 1995, she became the new company's first Vice President, Claims. In short order, she built the fledgling Claims group into a department that is often referred to as "best in class" among Canadian insurance claims operations. The principled approach to claims management that is now a LAWPRO trademark, the experience and expertise resident in the claims team, and its successful track record in representing the legal profession's interests are all evidence of her leadership at work. About a year ago, Caron announced her decision to transition to the new role of Counsel Emeritus at LAWPRO.



Those of us who were lucky enough to work with her every day will remember her quick and analytical mind, her generous and hearty laugh, her generous and kind spirit, and her courtesy, caring and compassion.

The legal community has lost one of its most stalwart advocates and friends.
